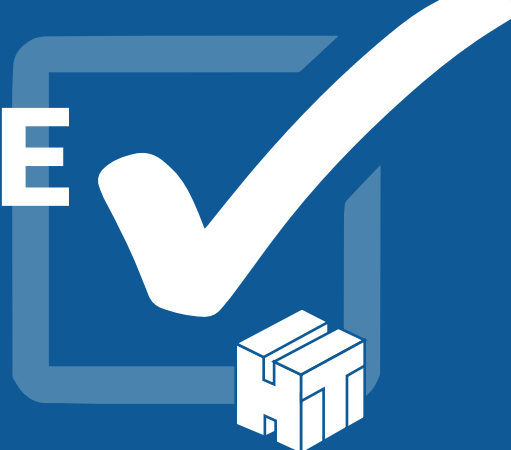

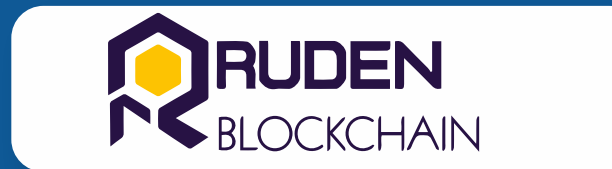

4.5.1 The price of a Bitcoin

As Bitcoin has no central issuer or regulator, the value of Bitcoins is highly volatile, the price of Bitcoins is purely driven by supply and demand for Bitcoins.

Bitcoin Group believes that the increasing Bitcoin Network's value will have a flow on effect in supporting current Bitcoin prices, therefore ensuring the a sizable market opportunity for sustained participation in the Bitcoin Mining as an industry.

As at 30 November 2015, the value of a Bitcoin is US\$376.24 or AU\$523.36¹⁴.
